

MARTINS FARM SWIMMING POOL RULES

For your safety and the protection of all homeowners, relatives and guests, the following rules are posted and will be enforced. As homeowners, we want to first ensure the safety of our swimmers and minimize any liability to the homeowners.

1. Any adult homeowner is empowered to enforce the rules of the pool. Homeowners or children who refuse to follow the rules enforced by adult homeowners should be reported to the Board. Failure to comply with the rules can result in suspension of access.
2. Absolutely No smoking in the pool area at any time.
3. No littering. All garbage should be placed in the garbage cans.
4. All babies who are not potty trained must wear swim diapers. (Regular diapers are NOT acceptable.)
5. No lifeguard on duty.
6. Children under the age of 14 must be accompanied by an adult. (Minimum adult age is 18.)
7. Children under the age of 18 may not swim alone. Adults should avoid swimming alone.
8. No glass, bottles (glass objects of ANY type) allowed in pool or pool area.
9. No food or drinks in the pool. (Food and drinks are permitted in the pool area but must be kept out of the pool. All drinks must be in a plastic or paper container.)
10. No animals are allowed in the pool or pool area.
11. Shower first before entering pool.
12. Persons having infectious or communicable diseases which can be transmitted by water shall not use the pool.
13. Persons with open cuts, wounds, or blisters shall not use the pool.
14. Spitting, spouting of water, and blowing nose, etc., in the pool is prohibited.
15. No running, boisterous or rough play. Only supervised water sports allowed.
16. No throwing inappropriate items into the pool.
17. Guests must be accompanied by a resident. AT ALL TIMES.
18. Pool area gate must be locked AT ALL TIMES. (Do not prop gate open.)
19. First aid kit is available for use and is located in the ladies room.
20. Maximum bather load: 260 persons.
21. Pool area hours of operation: 6:00 AM to 11:00 PM (Police will be called if anyone unauthorized is in pool area outside of normal hours of operation.)
22. A telephone is located across from the rest rooms.
23. No public display of inappropriate affection.
24. No excessive loud music or noise.
25. No smoking inside gated area. Smoking is allowed only outside the gate, near the bench.

ALL POOL KEYS ARE CURRENTLY ACTIVE. TO REMAIN ACTIVE YOU **MUST** DO THE FOLLOWING:

- 1) READ THE ATTACHED POOL RULES AND ARC INFORMATION.
- 2) FULLY COMPLETE AND SIGN THE INFORMATION LISTED BELOW.
- 3) RETURN THIS COMPLETED FORM TO CAROLYN NARREAU'S MAILBOX AT 482 GOLDEN MEADOWS CIRCLE.

RESIDENTS WHO HAVE NOT COMPLETED THE ABOVE WILL HAVE THEIR KEYS DE-ACTIVATED. TO RE-ACTIVATE THE KEYS:

- 1) COMPLETE 1 & 2 LISTED ABOVE.
- 2) CONTACT ANY BOARD MEMBER.
- 3) THEY WILL RE-ACTIVATE KEYS AS THEIR SCHEDULES ALLOW (USUALLY WITHIN A FEW DAYS).
